# Getting your business up to speed

#### elnvoicing

elnvoicing creates new levels of efficiency, accuracy and security - and for most businesses, getting set up should be simple.

To be elnvoicing capable, you only need to do two things:

- 1 Register to receive elnvoices
- 2 Get set up to send elnvoices

# elnvoicing for Software Providers:

# What you need to know



Getting set up to receive elnvoices is an easy process and requires little to no investment for most small businesses. Many business and accounting software products are already elnvoicing capable with many more progressively adding the functionality.



#### Step 1: Check your accounting or billing software package.

The first thing you need is elnvoicing capable accounting or invoicing software. You can see if your software is elnvoicing capable by checking the website of your software provider, the growing list on our website, or by asking your accountant.



#### **Step 2: Get registered.**

Your next step, is getting registered to receive elnvoices. This process varies - but in most cases, it's easy and free. Follow the instructions given by your software provider or check with your accountant. You can link to your provider's instructions from our 'elnvoicing software' page on einvoicing.govt.nz



## Step 3: Let your suppliers know.

Once you're registered, let your suppliers know that you'd prefer to receive elnvoices - not a PDF. They'll need your New Zealand Business Number (NZBN) to do this and they'll need to be elnvoicing-capable themselves.

There's a <u>supplier communications toolkit</u> available to help you encourage your suppliers to get elnvoicing capable and to begin sending you elnvoices.

# At that point, you're ready to go!

When you start getting elnvoices, you might see a different layout to a traditional PDF invoice, depending on your particular software package.

Rest assured, it's a genuine invoice that meets the IRD's requirements.

# How to send





## Step 1: Find your buyer's NZBN

You'll need the New Zealand Business Number (NZBN) of your customer, which is essentially the 'address' that you'll be sending your elnvoice to. If you don't have this on file already there are a range of search options at <a href="mailto:nzbn.govt.nz">nzbn.govt.nz</a>

If you're only looking for a few NZBNs, you can use the basic search function - and if you see multiple numbers for a business, reach out to your customer to confirm the correct one.

For businesses with many customers, the best option is to request an NZBN business match. Just export a list of your customers or suppliers and send it on to the Business Match service – which will provide these businesses' NZBNs back to you for free. nzbn.govt.nz/using-the-nzbn/nzbn-services

When you have your customer's NZBN - you can usually add it into a field in your accounting system's customer contact section, or use its 'upload' function to upload all customer NZBNs.



#### Step 2: Use your provider's process to create and send elnvoices

The process of sending an elnvoice varies from software to software - but in most cases, it's easy and free. Follow the instructions given by your software provider or check with your accountant. You can link to your provider's instructions from our 'elnvoicing software' page on <a href="mailto:einvoicing.govt.nz">einvoicing.govt.nz</a>



# Of course, you can only send elnvoices to buyers who can receive them

Check with your customers whether they've got that capability yet - then let your accounts team know to send elnvoices instead of PDFs.

## If you can receive elnvoices:

Add the following to your business's email signature for relevant roles (such as accounts payable team members or auto responses for AP enquiries):

"We prefer to receive elnvoices instead of PDFs. Our NZBN is (xxxxxxxxx)."

## If you can send elnvoices:

Add the following to your business's email signature for relevant roles (such as accounts & procurement team members) and onto your PDF or paper invoices:

"We prefer to send elnvoices instead of PDFs - to make it faster and easier for you to process our invoices. Let us know if your business can receive elnvoices, and your NZBN."
